George's Report:

1. Encouraging all gymnasts to participate in the MMG hosted summer camp August 3-7, 2009. Sign up as soon as possible.

3. Need donations of popsicles for the gymnasts.

Proposal:

Proposal presented would be to begin billing per gymnast instead of per family. If a family had two gymnasts they would receive a 25% discount for the second gymnast and a 50% discount on the third and any additional gymnasts.

Concerns regarding this proposal were:

- Impact on the family if a large increase is implemented all at once.
- How many families seek out MMG because of our current system of paying coaches fees?
- Need to look the cost if a smaller or no discount is given for multiple gymnasts per family versus the cost of the additional family members being spread out among all members of MMGBC.
- More than one option should be presented to the families for voting.

An e-mail from a member not able to attend the meeting was read regarding the history behind the current billing system (where additional family members currently pay \$50 each).

It was also discussed that a more feasible option would be to have the discount for additional family members be a percentage as opposed to a dollar amount.

At this time it was decided that this proposal will not be voted on by the membership but instead will be rewritten addressing the concerns presented at the meeting. The new proposal will then be voted on by all members in good standing with the MMG Booster Club.
