October 10, 2009

Booster Club Commitment Fees and Meet Fees: Jennifer Nowowastka

Last year Booster Club fees were divided up among 4 payments. Due to non-payment issues we are unable to offer that option this year.

This year Booster Club Commitment fees were billed based upon last years fees of \$450/team and \$250/pre-team. They were billed in July and were to be paid over the summer (July, August, & September). The commitment fee should have been paid by September 15, 2009. The budget was approved in September and the commitment fees for the 2009-2010 season are \$375/team and \$188/pre-team. That is less than last year fees.

**Commitment fees covers coach's fees, (\$75 per session per coach), coaches hotel and millage costs. It also covers the end of the season banquet, coach's gifts and other administrative costs. They DO NOT cover gymnast's meet fees.

The \$25 membership fee is billed every September. This allows membership into the Mid Michigan Gymnastics Booster Club (MMGBC) which includes voting rights (1 vote per family) and the right to fundraise. We must charge a membership fee because we are nonprofit.

By the end of October we need to register for four girl's meets and 2 boys meets.

Your Gymnast will not be entered into these meets unless the following has been completed:

1. MMGBC commitment fee has been paid (\$375/team or \$188/pre-team)
2. \$25 MMGBC membership fee has been paid
3. Booster Club Commitment agreement has been signed (place in the MMGBC Lock Box)
4. Tentative Meet Schedule distributed by the gym has been signed by a parent and gymnast and turned into MMG.

Billing statements from MMGBC will be placed in Gymnast's folders on November 1, 2009. They will have your credit for the Little Caesar Fundraiser. In addition will be the meet fees for entering your gymnast into the meets entered in October. **THE BALANCE OWED ON THIS STATEMENT WILL BE DUE DECEMBER 31, 2009.** If it is not paid your gymnasts will not be entered into any further meets.

Football Frenzy will not be on this statement but you will receive an e-mail with the amount earned per ticket sold (once that amount is known, based upon total number of tickets sold). You may then deduct the amount you earned (based upon the number of tickets you sold) from your balance due.

Duffle Bags: Jennifer Nowosatka

Duffle bags are required for team members and are optional for pre-team. Order forms have been distributed. Completed order forms and a check for \$24.50 payable to Saginaw Knitting Mills can be placed in Lauren Nowosatka's (level 8) folder.
