Budget for the 2009-2010 season was presented. Total budget for 2009-2010 will be \$27,323. This reflects an 8% increase from last year.

Booster Club commitment fees will be as follows: \$375 for first team gymnast per family, \$188 for first pre-team gymnast per family, \$131 each additional team gymnast per family, \$66 each additional pre-team gymnast per family.

Budget was approved by a show of hands.
